



Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.

The purpose of this modification is to provide incremental funding in the amount of \$155,000.00 to provide for continuation of services under the contract. Accordingly, the contract is modified as follows:

Under Section B.2, "Consideration and Obligation -- Delivery Orders (JUN 1988)," the first sentence under paragraph (b) is deleted in its entirety and replaced with the following:

"(b) The total amount presently obligated by the Government with respect to this contract is \$893,417.44."
