SUBJECT: AMENDMENT NO. 2 TO CERTIFICATE OF COMPLIANCE NO. 1026 FOR THE
FUELSOLUTIONS™ SPENT FUEL MANAGEMENT SYSTEM

Dear Mr. Quinn:

As requested by your application dated March 30, 2001, as supplemented, enclosed is Certificate of Compliance (CoC) No. 1026, Amendment No. 2 for the FuelSolutions™ Spent Fuel Management System. This certificate supersedes, in its entirety, CoC No. 1026, Amendment 1 effective May 14, 2001. Changes made to the certificate are indicated by vertical lines in the right margin. As stated in the Federal Register (66 FR 56982, 11/14/01), the effective date of this certificate is January 28, 2002. We request that you update and submit four copies of the final safety analysis report to conform to the certificate, as required by 10 CFR 72.248.

Amendment No. 2 to CoC No. 1026 constitutes U.S. Nuclear Regulatory Commission (NRC) approval of the following changes to the FuelSolutions™ Spent Fuel Management System:

1. TS 2.1, "Fuel to be stored in the FuelSolutions™ W74 canister" was revised to clarify the description of the other non-fissile material permitted to be in the fuel assembly.
2. TS 3.3.2, changed the temperatures to correspond to the liner thermocouple.
3. TS 3.3.2 and TS 3.3.3, changed required action "return canister to the fuel building and remove all assemblies" to "return canister to transfer cask", and added "return canister to repaired or replaced storage cask" within 270 days.

This certificate constitutes the approval and conditions for use of the FuelSolutions™ Spent Fuel Management System for storage of spent nuclear fuel under the general licensing provisions of 10 CFR 72.210. A general license has been granted to all holders of licenses for nuclear power reactors issued under 10 CFR Part 50.
