SUBJECT: AMENDMENT NO. 2 (MAINE YANKEE FUEL-RELATED COMPONENTS AND MISCELLANEOUS TECHNICAL SPECIFICATIONS CHANGES) TO CERTIFICATE OF COMPLIANCE NO. 1015 FOR THE NAC INTERNATIONAL, INC., UMS UNIVERSAL STORAGE SYSTEM

Dear Mr. Thompson:

As requested by your application dated October 17, 2000, as supplemented December 7, 2000, and April 27, July 5, July 18, July 19, July 26, and August 1, 2001, enclosed is Certificate of Compliance (CoC) No. 1015, Amendment No. 2, for the NAC International, Inc. (NAC), UMS Universal Storage system. This certificate supercedes, in its entirety, CoC No. 1015, Amendment No. 1 dated February 20, 2001. Changes made to the certificate are indicated by vertical lines in the right margin. As stated in the Federal Register (66 FR 52486, 10/16/01 and 66 FR 67073, 12/28/01), the effective date of this certificate is December 31, 2001. The staff's Safety Evaluation Report is also enclosed.

Amendment No. 2 to CoC No. 1015 constitutes U.S. Nuclear Regulatory Commission (NRC) approval of the following changes to the NAC-UMS system:

1. Changes to authorized contents to allow Maine Yankee to store various components associated with the spent fuel assemblies;
2. A Technical Specification change to delete the requirement to place a TSC in the transfer cask if the associated VCC's vents cannot be unblocked; and
3. Editorial clarifications, administrative changes and correction of discrepancies in the Technical Specifications (TS).

This certificate constitutes the approval and conditions for use of the NAC-UMS system for storage of spent nuclear fuel under the general license provisions of 10 CFR 72.210. A general license has been granted to all holders of licenses for nuclear power reactors issued under 10 CFR Part 50.
