The purpose of this modification is to provide incremental funding in the amount of \$120,000.00 to provide for continuation of services under the contract. Accordingly, the contract is modified as follows:

Under Section B.8, "Consideration and Obligation -- Work Orders (JUN 1988)" the first sentence of paragraph (b) is hereby deleted in its entirety and substituted with the following:

"The amount presently obligated with respect to this contract is \$389,000.00."
