

The purpose of this modification is to provide incremental funding in the amount of \$225,850.00, thereby increasing the obligated amount of the subject contract from \$1,070,000.00 to \$1,295,850.00. As a result, the subject contract is fully funded.

Accordingly, the following changes are hereby made:

Under Subsection B.18 - **Consideration and Obligation-Work Orders**, the first sentence of Paragraph (b) is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.18           **CONSIDERATION AND OBLIGATION-WORK ORDERS**

(b)     The amount presently obligated with respect to this contract is \$1,295,850.00."
