Comments of Chairman Meserve on COMNJD-02-0001

I support Commissioner Diaz's suggestion that the annual assessment of the impact of NRC's activities on reactor licensee's operations should periodically be supplemented by an independent survey by a qualified contractor. Because the collection and periodic evaluation of performance information can provide important insights, I suggest that the staff also consider whether the periodic collection and evaluation of feedback should be extended to other classes of licensees. The staff should provide a recommendation as to the appropriate interval for such assessments.

I also support Commissioner Merrifield's recommendation that the staff provide its views on how to proceed with the independent surveys, including appropriate frequency and cost estimates.




