Involving the public is an important part of developing any federal undertaking. Under the Section 106 regulations of the Advisory Council on Historic Preservation (36 CFR Part 800), federal agencies are responsible for identifying individuals and organizations that may have an interest in undertakings of your agency. These individual organizations, known as other potential consulting parties, are in addition to the requirement to request consultation with local governments, applicants for federal assistance, permittees, or licensees. In an effort to assist you in identifying other potential parties, we have prepared the enclosed listing. We hope these lists will assist your agency in expediting the requirements to identify persons and/or organizations who may have pertinent information to share regarding the identification of historic properties within a project's Area of Potential Effect, as well as an interest in how projects may affect historic properties for which they have an interest and concern.

While it is not possible to identify specific individuals in advance of an undertaking, we have identified some organizations who may have an interest in a specific project at any given time or location. We have compiled lists of local governments, several historical societies, as well as civic and community organizations who have expressed interest in historic preservation. These lists contain the names of these organizations, a contact person, address and phone as of - (date where available) and are presented geographically in the enclosed disk. This is not a complete list and it remains the federal agencies responsibility to identify interested parties. The date on these lists is only as accurate as the information provided to us and may be subject to change at any time. It is our intent to annually update and distribute these lists. To protect the privacy of these organizations and their members, we request these lists be used for your agency's compliance purposes only and not to be released to a third party. Finally, the list file is formatted in Microsoft Word (.doc), Word Perfect (.wpd), ASCII (.txt), and Rich Text Format (.rtf) allowing you to read and download. If you cannot open the file, please contact Mary Harper at the above address.
