Perry's letter of January 30, 2002 to Chairman Meserve in which he requested a listing of all contracts that the U.S. Nuclear Regulatory Commission (NRC) has with Arthur Andersen, LLP, and Enron Corporation. The enclosed table includes the basic information requested.

The NRC does not have any contracts with Enron, nor do we have any previous or current contracts for auditing services with Arthur Andersen. Arthur Andersen has provided assistance to the NRC in the area of process planning and program assessment expertise and, in this context, the NRC has two current contracts with Arthur Andersen. On February 5, 2002, we completed a review of the contract file documentation for these awards. The review team did not identify any performance problems or circumstances which would preclude Arthur Andersen from completing these contracts. Should such circumstances arise in the future that would preclude Arthur Andersen from completing current contracts, NRC will notify you and initiate appropriate corrective action at that time. Finally, NRC does not have any imminent contract awards to either Enron or Arthur Andersen.

We have not provided detailed information concerning completed contracts. However, the Office of the Inspector General has informed the Commission that it is currently conducting an investigation, which it describes as involving integrity matters in connection with the award of a recently completed contract.
