PERFORMANCE DATA AND SUMMARY OF MANAGEMENT ACTIONS

Medical Review Officer (MRO) Six Month Report

From July 1, 2001, through December 31, 2001, our records indicate the following results:

In the Pre-Access program category, in the short-term contractor personnel pool, three (3) confirmed positives for single substance and two (2) refusals to test, by MRO adjudication due to specimen adulteration, were experienced. There was one (1) confirmed positive for two (2) substances experienced in the For Cause-Observed Behavior program category, for long-term contractor personnel. There were no confirmed positives in the licensee program categories.

Pre-Access Program

In the Pre-Access program category, short-term contractor personnel pool, three (3) confirmed positives for a single substance were experienced. Two (2) additional specimens were confirmed as adulterated samples and by MRO interview, adjudicated as positive – refusal to test. Each individual participated in separate face-to-face interviews with the Medical Review Officer and were provided the opportunity for split-specimen testing. One (1) individual elected to forward the split sample to the back-up laboratory and a repeat confirmed positive result was reported. The Medical Review Officer adjudicated all three (3) individuals as confirmed positive and unescorted access was denied. The two (2) individuals providing the adulterated samples were adjudicated by the Medical Review Officer, as a refusal to test and permanently denied unescorted access.

For Cause - Observed Behavior

In the For Cause – Observed Behavior program category, long-term contractor pool, one (1) confirmed positive for two (2) substances was experienced. The individual participated in a face-to-face interview with the Medical Review Officer and declined the opportunity for split-specimen testing. The Medical Review Officer adjudicated the individual as a confirmed positive and unescorted access was denied.

List of Events Reported

During the period of July 1, 2001 through December 31, 2001, no events were reported under the provisions of 10 CFR 26.73 by Beaver Valley Power Station (BVPS).
