The Commission has issued the enclosed Amendment Nos. 93 and 118 to Facility Operating License Nos. DPR-71 and DPR-62 for the Brunswick Steam Electric Plant, Units 1 and 2. The amendments consist of changes to the Technical Specifications in response to your submittal of July 8, 1985.

The amendments change the Technical Specifications to delete the Service Water Effluent From Augmented Off-Gas Precooler Radioactivity Monitor from Tables 3.3.5.8-1 and 4.3.5.8-1. The monitors are no longer necessary as these precoolers have been bypassed.

A copy of the related Safety Evaluation is also enclosed.
