This MD was previously entitled "Evaluating the Safety Performance of Nuclear Power Reactor Licensees," but has been revised to reflect the new Reactor Oversight Process (ROP) that was implemented on April 2, 2000. Attached is a Form 521 to request issuance of the revised MD 8.13.

As background, NRR issued a draft of the revised MD 8.13 in March 2000 for use and comment as part of initial implementation of the ROP. NRR revised the draft MD to incorporate lessons learned from initial implementation, and re-issued the MD for comment in December 2001 to the NRC offices that were affected by the changes to the draft MD. Attached is a table listing all comments received on both versions of the draft MD 8.13 and their resolutions.
