Dear Mr. Bakken:

This letter refers to an investigation conducted by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI) to determine if an electrical engineer was the subject of discrimination at the D. C. Cook Plant for raising safety concerns. Based on the evidence developed during the investigation, we did not substantiate that the electrical engineer was the subject of discrimination for raising safety concerns. The synopsis from the OI report of investigation is enclosed.

Normally, based on our evaluation, we would consider this matter closed. However, because the concerned individual in this case has a complaint pending with the Department of Labor (DOL) we will review the results of the DOL proceeding to determine if additional NRC action is warranted.

OI SYNOPSIS (3-2000-054)
