 PERFORMANCE REPORT
 July 1, 2001 through December 31, 2001**

During the second performance period of 2001, the STPNOC FFD Program conducted a total of 1140 FFD screening tests that resulted in five positive test results. The positives were comprised of short-term contractors whose unescorted access was denied. STPNOC conducted 383 random tests resulting in a random testing rate of 42% of the average annual population with an annual random testing rate of 57%.

STPNOC did not have any 10CFR26.73 reportable events during the performance period.
