Dear Mr. Hill:

We have reviewed the proposed Georgia regulations, Rules and Regulations for Radioactive Materials, Chapter 391-3-17, which were dated October 16, 2001, resubmitted electronically with changes on December 10, 2001. The proposed regulations were in Section .01, General Provisions; Section .02, Licensing of Radioactive Material; Section .03, Standards for Protection Against Radiation; Section .04, Special Radiation Safety Requirements for Industrial Radiographic Operations; Section .05, Use of Radionuclides in the Healing Arts; Section .06, Transportation of Radioactive Material; Section .07, Notices, Instructions, and Reports To Workers; Section .09, Licensing and Radiation Safety Requirements for Irradiators; and Section .11, Administration. The proposed regulations are in response to the 16 amendments identified in the enclosed State Regulation Status (SRS) Data Sheet, and proposed amendments to 10 CFR Part 35.

On December 18, 2001, Mr. Woodruff of our Region II office discussed his preliminary review with you, and during the discussion it was noted that the provisions of Section .02 concerning general licenses (GL) are matters of compatibility. Specifically, 65 FR 79162, published December 18, 2000, effective, February 16, 2001, modified requirements for general licensees and for distributors of GL devices. An early compatibility requirement was to be implemented by Agreement States by August 15, 2001. Much of the remainder of the rule revision was compatibility Category B. NRC recommends that Georgia incorporate the compatibility requirements for the entire GL rule amendment at the State's earliest convenience but not to exceed the implementation deadline of February 2, 2004.

As a result of our review, we have ten comments and three editorial suggestions that have been identified in the enclosures. Please note that we limited our review to regulations required for compatibility and/or health and safety. Under our current procedure, a finding that a State regulation meets the compatibility criteria of the equivalent NRC regulation may only be made based on a review of the final State regulation. However, we have determined that if your proposed regulations were adopted incorporating the comments and without other significant change, they would meet the compatibility and health and safety categories established in Office of State and Tribal Programs (STP) Procedure SA-200.

We request that when the proposed regulations are adopted and published as final regulations, a copy of the "as published" regulations be provided to us for review. As requested in STP Procedure SA-201, *Review of State Regulations* (November 10, 1998), please highlight the final changes and send one copy to STP.
