Subject: Byron Station Security Plan, Revision 63

In accordance with 10 CFR 50.54(p)(2), "Conditions of licenses," we are submitting a change to the Exelon Generation Company, LLC, Byron Station Security Plan. In accordance with 10 CFR 50.4(b)(4), "Security plan and related submittals," attached are the original and three copies of Revision 63.

Revision 63 includes the following changes.

The Security Plan has been revised to allow ammunition to be stored with contingency weapons. There is no regulatory requirement limiting the storage of weapons and ammunition in the same location. The weapons and ammunition will continue to be secured as currently required by the Security Plan. This change is an enhancement to the existing defensive strategy.

The Security Plan has been revised to allow security management the ability to approve laydown areas, for the storage of equipment and material, that are within close proximity to the isolation zone provided that measures are taken to assure that observation of the isolation zone is not decreased.

These changes are summarized in Attachment 1, "Byron Station Security Plan, Revision 63 Change Matrix."

As required by 10 CFR 50.54(p)(2), we have concluded that these changes do not decrease the safeguards effectiveness of the Byron Station Security Plan.
