By letter dated February 15, 2002, the licensee submitted responses to our request for additional information regarding the transfer of operating authority under the facility operating license from ENG C to ENO. Contained in the February 15, 2002, response was an affidavit requesting that certain financial projections related to the operation of Pilgrim Station be withheld from public disclosure. However, the affidavit was not dated by the person signing the affidavit. After discussion with OGC, we determined that it was appropriate to use the date of the letter, February 15, 2002, as the date of the affidavit. Additionally, on February 26, 2002, I left a voice mail message for Bryan Ford, Pilgrim Station Licensing Manager, requesting that he confirm via e-mail that the licensee's intent was that the date of the affidavit be the same as the date of the letter, February 15, 2002.
