

Proposed San Francisco Bay Plan Amendment No. 1-02 Concerning Amendment of the Bay Plan Recreation Findings and Policies and the Bay Plan Map Notes and Waterfront Park, Beach Priority Use Area Designations that Pertain to Military Bases Designated for Park Priority Use.

Notice is hereby given that the San Francisco Bay Conservation and Development Commission will consider an amendment to the *San Francisco Bay Plan*. The proposed amendment would: (1) revise the recreation policies that pertain to military bases designated for park priority use; (2) update the Bay Plan Map notes that recommend recreational uses on these military bases; and (3) update the Bay Plan waterfront park, beach priority use area designations of the military bases designated for park priority use. This approach to the amendment of the Bay Plan recreation findings and policies will allow for a timely response to proposed and pending projects on the decommissioned military base lands along the Bay shoreline.

A **Public Hearing** on the possible amendment will be held on **May 2**, **2002** at the Port of San Francisco, Pier 1, The Embarcadero, Bayside Conference Room, San Francisco, California, starting at 1:00 P.M. At least thirty days prior to the initial meeting, the staff will prepare and mail a staff report and preliminary recommendation on the proposed amendment. Interested persons may request the staff report and present written comments on or before May 2, 2002. Oral comments may be presented at the May 2, 2002 Commission meetings or thereafter as directed by the Commission.

This Notice is prepared in conformance with Section 66652 of the California Government Code, Section 11001 of Title 14, Division 5 of the California Code of Regulations, and Section 312 of the federal Coastal Zone Management Act of 1980. If, after the hearings, the Commission adopts an amendment to the *San Francisco Bay Plan* described in this notice and subsequent staff report, such amendment will be processed as a routine program change of the Commission's federally-approved coastal management program for San Francisco Bay. Any federal agency interested should, therefore, comment to the Commission on or before May 2, 2002.

Whether the Bay Plan should be amended as described above, and in what manner, will be the subject of the public hearings and Commission deliberations.
