In response to your November 15, 2001, letter requesting the permanent transfer of 1,494 cubic feet of U.S. Nuclear Regulatory Commission (NRC) records stored at the Washington National Record Center (WNRC), we have enclosed the SF 258, "Agreement to Transfer Records to the National Archives of the United States," and your list with lines through thirty-six accession numbers, totaling 533 cubic feet of records, that are disapproved for transfer at this time. The remaining 56 NRC accession numbers, totaling 955 cubic feet of records, have been approved for permanent transfer. However, boxes 31 and 32 from accession number 431-93-0010 and box 33 from accession number 431-93-0011 have been disapproved for transfer. These boxes will be retained by the agency at the WNRC because they contain information that NRC considers sensitive in light of the September 11th terrorist attacks, and should not be relinquished before guidance has been issued by the Commission for handling information of this nature. In addition, boxes 3, 4, and 5 from accession number 431-01-0907 are also disapproved because they were inadvertently classified as permanent records.

The 36 accession numbers, totaling 533 cubic feet, have been disapproved for the following reasons:

- Three accession numbers (431-01-0434, 431-01-2312, and 431-01-2316), totaling 5 cubic feet, have disposition dates of 2034, 2031 and 2018 respectively, and two accession numbers (431-01-0934 and 431-01-936), totaling 7 cubic feet, were inadvertently classified as permanent records.
- Six accession numbers (431-01-0638, 431-01-0690, 431-01-0695, 431-01-0700, 431-01-0702, and 431-01-0709), totaling 69 cubic feet, are not eligible for transfer, they must be retained at the agency for the life of the Advisory Committee on Reactor Safeguards (ACRS) and the Advisory Committee on Nuclear Waster (ACNW). As a result of an agreement with NARA and the WNRC, these records will be reviewed at ten year intervals as long as the ACRS and ACNW exist.
