Dear Mr. Davis:

This letter is in reference to the unresolved item identified in a Nuclear Regulatory Commission (NRC) inspection conducted on May 14-18, 2001. NRC policy defines an unresolved item as a matter about which more information is required to determine whether the issue in question is an acceptable item, a deviation, a nonconformance, or a violation. The unresolved item, 72-1015/01-202-01, involved a calculation that had engineering judgments and assumptions which did not have adequately documented technical bases as required by NAC procedures.

Subsequent to the inspection, your staff provided additional information in the form of clarifying calculations on September 24, 2001, and January 10, 2002, and participated in telephone conference calls with my staff on October 4, and December 19, 2001. The information you provided established an adequate basis that demonstrated that the engineering judgments and assumptions made in the calculation were adequate. Consequently, the unresolved item is closed. A violation is not considered warranted since the questioned judgements and assumptions were demonstrated to be sound.
