By letter dated August 23, 1999, the U.S. Nuclear Regulatory Commission issued Amendment No. 185 to Facility Operating License No. DPR-72 for Crystal River Unit 3. The amendment was in response to Florida Power Corporation's request dated July 30, 1998, as supplemented April 8 and July 8, 1999. The amendment changed the Improved Technical Specifications (ITS) regarding the Control Room Emergency Ventilation System and the Ventilation Filter Test Program.

The page titled, *Attachment to License Amendment No. 185*, listed the pages to be removed and the new pages to be inserted. Under the *Remove Page* column, page 5.0-22 was inadvertently included.
