An Order was issued on September 8, 1999, providing U. S. Nuclear Regulatory Commission approval of the pending transfer of the license for Crystal River Unit 3, to the extent it is held by the City of Tallahassee, to Florida Power Corporation (FPC) and approval of a conforming amendment which reflected the transfer. The conforming amendment is to be issued and made effective at the time the license transfer is completed. By letter dated September 22, 1999, FPC informed us that the license transfer would be completed on October 1, 1999. Therefore, we have issued the enclosed Amendment No. 189 to Facility Operating License No DPR-72 for Crystal River Unit 3, with an effective date of October 1, 1999.

1. The Nuclear Regulatory Commission (the Commission) has found that:
 - A. The application for amendment by Florida Power Corporation et al. (the licensees), dated December 29, 1998, as supplemented June 18, 1999, complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's rules and regulations set forth in 10 CFR Chapter I;
 - B. The facility will operate in conformity with the application, the provisions of the Act, and the rules and regulations of the Commission;
 - C. There is reasonable assurance (i) that the activities authorized by this amendment can be conducted without endangering the health and safety of the public and (ii) that such activities will be conducted in compliance with the Commission's regulations;
 - D. The issuance of this amendment will not be inimical to the common defense and security or to the health and safety of the public; and
 - E. The issuance of this amendment is in accordance with 10 CFR Part 51 of the Commission's regulations and all applicable requirements have been satisfied.

1. The Nuclear Regulatory Commission (the Commission) having found that:
 - A. The application filed by Florida Power Corporation, City of Alachua, City of Bushnell, City of Gainesville, City of Kissimmee, City of Leesburg, City of New Smyrna Beach and Utilities Commission, City of New Smyrna Beach, City of Ocala, Orlando Utilities Commission and City of Orlando, Sebring Utilities Commission*, Seminole Electric Cooperative, Inc., and City of Tallahassee** (the licensees) as supplemented by letter dated December 9, 1976, complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act) and the Commission's rules and regulations set forth in 10 CFR Chapter 1;
 - B. Construction of the Crystal River Unit 3 Nuclear Generating Plant (facility) has been substantially completed in conformity with Provisional Construction Permit No. CPPR-51 and the application, as amended, the provisions of the Act and the rules and regulations of the Commission;
 - C. The facility will operate in conformity with the application, as amended, the provisions of the Act, and the rules and regulations of the Commission;
