*** Funding was not requested because NRC plans to use the utility energy services contract (UESC) to accomplish energy conservation projects. The UESC is an alternative financing program which requires no capital funding from Federal agencies. The monetary savings achieved from the projects performed by the contractor are used to pay for the projects.

**** Preliminary audits of OWFN and TWFN were conducted in FY 2000.

***** An ESCO contractor was selected in FY 2000. The ESCO could not identify any viable projects.

***** UESC has conducted a preliminary audit. The terms and conditions of the contract are being reviewed to determine if a task order can be issued in FY 2002.

***** NRC is not responsible for the design or construction of new facilities. No major renovations at the NRC's White Flint complex began in FY 2001.
