The purpose of this modification is to: (1) allow for an administrative change which revises the effective date of Modification No. 13 under the subject contract from January 22, 2001 to January 22, 2002; and (2) revise Paragraph C.2.3 - Modifications/Enhancements to Operations Center Information Management (OCIM) System, to allow the NRC Project Officer the authority to issue delivery orders for software purchases in accordance with Paragraph G.4 - Ordering Procedures of the subject contract.

Accordingly, the following changes are hereby made:

1. Under Modification No. 13, Block 16C of Standard Form 30, is hereby revised to change the effective date of the modification from January 22, 2001 to "January 22, 2002".
2. Under Section C - Description/Specifications/Statement of Work, Paragraph C.2.3 - Modifications/Enhancements to Operations Center Information Management (OCIM) System, is hereby deleted in its entirety and substituted in lieu thereof the following:

"2.3 Modification/Enhancements to OCIMS

The contractor shall upgrade software as necessary to keep RCS and HOO DB systems operating at peak performance levels (no more than 4 hours down time). This includes updating agency supplied software when notified by the NRC Project Officer that an updated version is available. Such software upgrades shall be made within 30 days after receipt of the software upgrade from the NRC Project Officer or by a specified time as directed by the NRC Project Officer. The NRC shall provide upgraded agency standard software and the contractor shall purchase non-agency standard software. The contractor shall be required to adhere to the following procedures for all software purchases upon receipt of a delivery order issued in accordance with Paragraph G.4 - Ordering Procedures:

- (a) Any required contractor purchases for non-agency standard software in excess of \$1,000 per item or \$2,500 per delivery order, requires the prior approval of the NRC Contracting Officer. For all software purchases that exceed the above amounts, the contractor shall be required to submit data to the NRC Contracting Officer for approval, to include three quotations, either under the General Services Administration's Federal Supply Schedule or open market, or a combination thereof, which will satisfy the Government's minimum requirements prior to purchasing any software. Upon approval of the purchase, the Project Officer will re-issue the delivery order to the contractor, which will reflect the signature of the Contracting Officer.
- (b) Purchases below the amounts reflected in Paragraph a. above will be ordered by the Project Officer by issuance of a delivery order.

- (c) Each delivery order issued by the Project Officer will reflect the specific Government requirements, to include, quantity, delivery time, and place of delivery.
- (d) Contractor furnished software shall be acquired by the contractor on a cost reimbursable basis and, therefore, shall become Government furnished property in accordance with Paragraph H.18 - Government Furnished Property and Services of this contract.
- (e) The contractor shall be required to update Attachment 4 of this contract, within 30 days, when additions and/or deletions are made to the NRC OC Software List. Upon revision of the Software List, a copy shall be provided to the NRC Project Officer for a subsequent contract modification which will incorporate the revised list.
- (f) The contractor shall maintain awareness of and evaluate the availability of (as directed by the NRC Project Officer) upgrades for network-related software in place at the start of this contract, the registration of all commercial software purchased by the contractor, and establishment of procedures to ensure adherence to software licenses.
- (g) The contractor shall make enhancements to any of the subsystems when requested by the NRC Contracting Officer which may include software enhancements and/or upgrades, hardware upgrades, programming modifications, and other items. Any modification and/or enhancement to the OCIMS that may cause an increase to the contract ceiling price, the contractor shall be required to submit a technical and cost proposal to the NRC Contracting Officer for approval and subsequent modification to the contract.
- (h) The contractor shall present suggested modifications/enhancements to the OCIMS to the Government prior to the start of any work. Upon approval, the NRC Contracting Officer will authorize each modification/enhancement by issuance of a modification to the contract in accordance with the Changes Clause of this contract."

All other terms and conditions under this contract, including the contract ceiling amount of \$1,221,048.25, remains unchanged as a result of this modification.
