The purpose of this modification is to (1) provide incremental funds to fully fund the subject contract, and (2) extend the period of performance of the contract at no additional cost to the NRC through May 31, 2002 (NOTE: The deliverable dates remain as stated under the contract). Accordingly, the following changes are hereby made:

1. Section B.3, "CONSIDERATION AND OBLIGATION--COST REIMBURSEMENT," paragraph b, the first sentence is deleted in its entirety and replaced with the following:

"(b) The amount presently obligated by the Government with respect to this contract is \$875,000.00."

2. Section F.6, "DURATION OF CONTRACT PERIOD," is deleted in its entirety and the following is substituted in lieu thereof:

"This contract shall commence on the effective date of this contract and will expire on May 31, 2002."

All other terms and conditions under this contract remains unchanged.
