Gentlemen:

The Reference issued a U.S. Nuclear Regulatory Commission (NRC) Order to Wolf Creek Nuclear Operating Corporation (WCNOG) that modifies the current operating license for Wolf Creek Generating Station, Unit 1. The Order was effective immediately and requires compliance with specific interim safeguards and security compensatory measures as stated in Attachment 2 to the Order.

The Order requires a twenty-day response. Attachment 1 to this letter provides the twenty-day response for WCNOG. Attachment 2 provides a list of the commitments contained in this letter. Attachment 3 (Safeguards Information) is a description of the actions being taken by WCNOG to comply with the Order.

In a few instances we are unable to complete the necessary evaluations to determine what actions are appropriate and what an appropriate schedule for implementation would be within


