


The purpose of this modification is to reduce the ceiling and obligation amounts under the contract in the amount of \$4,185.92, thereby decreasing the obligated amount of the contract from \$114,504.75 to \$110,318.83. Accordingly, the contract is hereby modified as follows:

Subsection B.4, CONSIDERATION AND OBLIGATION--FIRM FIXED PRICE is deleted entirely and replaced with the following:

- "(a) The firm fixed price of this contract is \$110,318.83.
- (b) The amount presently obligated with respect to this contract is \$110,318.83."

All other terms and conditions of this contract remain unchanged.
