

The purpose of this modification is to deobligate funds in the amount of \$4,634.38 from the subject contract, thereby decreasing the obligated amount from \$1,562,000.00 to \$1,557,365.60.

Accordingly, the following change is hereby made:

Under Paragraph B. 4 - Consideration and Obligation-Work Orders, the first sentence of Subparagraph (b) is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.4 CONSIDERATION AND OBLIGATION-WORK ORDERS

- (b) The amount presently obligated by the Government with respect to this contract is \$1,557,365.60."
