As a result, many of the requirements imposed by the Order Modifying Licenses (Order) are already substantially in place and we have begun implementation of remaining requirements as delineated herein.

Attachment 1 to this response contains safeguards information, as defined in 10 CFR §73.21. Entergy therefore requests that this attachment be withheld from public disclosure


