SUMMARY: The plant entered February at 100% power. On February 1, at approximately 05:00, power level was reduced to approximately 65% to allow for troubleshooting of degraded vacuum in the "B" auxiliary condenser. Power level was restored to 100% at approximately 11:45 the same day. Design electrical rating and maximum dependable capacity will be revised during the second quarter 2002.
