3) Transportation and Route Schedule

The vessel will sail from Hamburg, Germany on October 21, 2001. The ocean transportation from Hamburg, Germany to Montreal, Quebec, Canada will be the responsibility of CANMAR Steamship Line. The vessel will unload at Montreal, Quebec, Canada on or about October 29, 2001. The containers will then be loaded onto the rail for importation to Detroit, MI. The containers will enter the USA at Detroit, MI on or about November 2, 2001, and will continue on rail to St. Louis, MO. The inland transportation from Montreal, PQ to Metropolis, IL will be the responsibility of RSB logistic Services Inc.


