Dear Mr. Jakoby:

This is in reference to the letter dated January 22, 2002, (enclosed) from the Oak Ridge Institute for Science and Education (ORISE) providing the NRC with the results of analyses of samples collected at the Royersford Wastewater Treatment Facility (RWTF). Sludge, filtrate, and filter cake samples were collected by RWTF personnel during the period of October 11-23, 2001, when mechanical dewatering of secondary digester sludge last occurred. Results indicate increases in the concentrations of radionuclides in the filtrate and secondary digester sludge compared to similar samples in previous years. The concentrations of radionuclides in the filter cake was within the range of previous filter cake samples.

Also enclosed is a letter dated March 8, 2001, from ORISE providing a revised report of the results of samples collected during the period of August 12-September 2, 1999. The original report listed the units of strontium-90 as a wet-weight measurement, when it should have stated dry-weight.
