SUBJECT: SUMMARY OF FEBRUARY 27, 2002, REGULATORY PERFORMANCE
MEETING WITH ENTERGY NUCLEAR OPERATIONS, INC.

On February 27, 2002, at 1:00 p.m., a meeting was conducted in the NRC Public Meeting Room in King of Prussia, PA, between the Nuclear Regulatory Commission (NRC) staff and Entergy Nuclear Operations, Inc. The purpose of the meeting was to discuss the status of performance improvement efforts at Indian Point Unit 2 (IP2), a plant with multiple degraded cornerstones under the NRC's Reactor Oversight Process.

The meeting was opened by Brian Holian, Deputy Director of the Division of Reactor Projects, who noted that this regulatory performance meeting was scheduled to discuss further, with NRC technical coordination team members, Entergy's Fundamentals of Improvement Plan (FIP).

Mr. Holian then briefly summarized past and recent IP2 performance, noting that the plant is being operated safely while Entergy continues with their plans to bring about needed improvements. Entergy began their presentation by discussing how the FIP was established, including its relationship with their site Improvement Plan. This was followed by discussion of IP2's design control and licensing basis documentation improvement efforts and FIP performance indicators in this and other areas. During the meeting, the NRC questioned Entergy on the FIP and on its various performance indicators.

At the end of the discussion between Entergy and NRC, the public attendees were offered the opportunity to ask questions of NRC officials. Of the four members of the public that attended the meeting, only one individual had a general comment about performance indicators which was addressed by the NRC. No additional followup was required. Please refer to Accession No. ML020560522 for all documents related to this meeting.
