**Changes to the
Report to Congress on Abnormal Occurrences for Fiscal Year 2001
NUREG-0090, Vol. 24**

1. Page vii, 4th paragraph, last sentence: insert a comma between “AOs” and “but”
2. Page vii, 6th paragraph, change line 1 to read: “... *Federal Register* notice describing”
3. Page 1, 3rd paragraph, change line 1 to read: “... event, ~~that~~ **which** occurred at”
5. “... ~~authorized by an NRC license~~ **licensed by the Atomic Energy Commission, NRC’s predecessor**, to possess”
6. Page 2, 3rd paragraph, line 4: add a new sentence: “... millisievert (263 rem). **The consultant has seen a doctor, had one therapeutic medical treatment, and no adverse health effects are expected.** The licensee”
7. Page 3, 6th paragraph, under “Licensee”, move last sentence to the end of paragraph four, “Nature and Probable Consequences”, and change it to read: “... 392 mSv (39.2 rem). ~~The licensee performed a cytogenetic test to evaluate the radiography overexposures.~~ **For the radiographer with the highest exposure, blood tests were normal and he declined further testing. No adverse health effects are expected.**
8. Page 10, 3rd paragraph, change line 1 to read: “... Unit 3 (ONS3) **shutdown** in Mode”
9. Page 10, 3rd paragraph, add new sentence to end of paragraph: **Appropriate repairs were completed.**
10. Page 11, 2nd paragraph, change line 5 to read: “... refueling outages **and appropriate repairs are being made prior to returning the plants to operation.** The staff “
11. Page 11, 5th paragraph, line 1: insert a comma between “incidents” and “the NRC”
12. Page 11, 11th paragraph, correct lines 2 and 3 to read: “... portable gauge that contained ~~1.48~~ **0.3** gigabecquerels (GBq) [8.5 millicurie (mCi)] of cesium-137 and ~~0.3~~ **1.8** GBq (49 mCi) of americium-241.”

Changes to Congressional letters

1. On both Congressional letters, combine the existing second and third paragraphs. Add a new closing paragraph that states:

“In addition to this report to Congress, NRC is issuing a Federal Register notice describing the NRC and Agreement State licensee AOs and announcing publication of the report.”
