George:

We are reviewing your September 11, 2001, application for changes to the Oyster Creek Technical Specifications. We would like to hold a conference call with your people to discuss these issues:

1. Information re. which cycle operation is applicable to this amendment request and types of fuel assemblies loaded for this applicable cycle operation. Also, results of analyses to show that the SLMCPR value in the TS now has no change for the coming cycle operation.

If the reactor core contains GE14 fuel in the coming cycle operation, we'll also discuss:

2. Discrepancies in the GEXL14 data bases identified during an audit of General Electric's GEXL14 correlation analysis. Discuss why the overall GEXL14 uncertainty for Browns Ferry Unit 3 is still valid. Discuss the impact of these discrepancies on the SLMCPR calculation due to these discrepancies.
