

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.

## CONTINUATION PAGE

The purpose of this modification is (1) to exercise Option Year 2 of the contract and (2) designate a new NRC Project Officer for the contract. Accordingly, the contract is hereby modified as follows:

1. Option Year 2 is hereby exercised in accordance with FAR 52.217-9 at the prices set forth in Section B.1. As a result, the contract ordering ceiling set forth in Section C.3 is hereby increased by \$133,390 from \$384,410 to \$517,800. As a result, Section C.3 is hereby deleted and replaced by the following Section C.3:

## C.3 CONSIDERATION AND OBLIGATION--DELIVERY ORDERS (JUN 1988)

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$517,800. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.

(b) The amount presently obligated with respect to this contract is \$156,500. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

2. In addition, the contract expiration is changed to April 29, 2003. As a result, Section C.4 of the contract is changed to read as follows:

## C.4 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 1 (JUN 1988)

The ordering period for this contract shall commence on 4/30/99 and will expire 4/29/2003. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering). The term of this contract may be extended at the option of the Government for an additional one-year term.
