

The purpose of this modification is to (1) revise Sections B.1, Price/Cost Schedule-Fixed Price, and B.1.1.b, Consideration and Obligation Delivery Order, to change language concerning funding coverage for Tasks I - V, and (2) revise Section C.4, Key Personnel, to modify the list of consultants under the subject contract in accordance with the contractor's letter dated 3/5/02. Accordingly, the contract is hereby modified as follows:

1. Section B.1, Price/Cost Schedule-Fixed Price, the last paragraph on Page B-1 specifying funding coverage is deleted in its entirety and replaced with the following:

a. "*Funds currently obligated are to cover Line Item Nos. I - V above not to exceed the obligated amount referenced in Section B.1.1.b of the subject contract."

b. Section B.1.1.b., Consideration and Obligation Delivery Order, the second sentence is deleted in its entirety and replaced with the following:

"Note: These funds are to cover Line Item Nos. I - V from the Contractor's proposal not to exceed the current obligated amount as stated."

2. Section C.4, Key Personnel, subparagraph a. is deleted in its entirety and replaced with the following:
