In accordance with 10 CFR 50.54(p)(2), "Conditions of licenses," we are submitting a change to the Exelon Generation Company, LLC, LaSalle County Station Security Plan. In accordance with 10 CFR 50.4(b)(4), "Security plan and related submittals," attached are the original and three (3) copies of Revision 67.

Revision 67 includes the following change.

The Security Plan has been revised to add alternate, NRC approved, methods for obtaining information pertaining to military records.

As required by 10 CFR 50.54(p)(2), we have concluded that this change does not decrease the safeguards effectiveness of the LaSalle County Station Security Plan.

The change to the LaSalle County Station Security Plan was implemented on January 24, 2002. In accordance with 10 CFR 50.54(p)(2), these changes shall be reported within 60 days of implementation (i.e., March 25, 2002).

Attachment 2 contains Safeguards Information that must be protected from public disclosure as required by 10 CFR 73.21, "Requirements for the protection of safeguards information."


