We acknowledge receipt of your letter dated March 1st, 2002 and the appended Nuclear Regulatory Commission (NRC) written evaluation and decision regarding our Reply to the above referenced NOV submitted on January 31, 2002.


Through said letter RESE is required to submit a second written statement or explanation replying to the confirmed NOV within thirty (30) days from the date of the letter. For reasons beyond RESE's control, we will not be able to submit the requested written statement within the aforesaid time frame.

On March 19, 2002, Redondo Cosntruction Corporation ("RCC") sought the protection of the Federal Bankruptcy Court for the District of Puerto Rico by filing a Chapter 11 procedure. (Please refer to the copy of the docket of the bankruptcy case number 02-02887 attached hereto). At this point, RESE is

evaluating the effects, if any, of said bankruptcy procedure on the matter at hand.

For the above stated reasons, we are hereby requesting an extension to the response time until April 30, 2002 in order to adequately and responsibly address the concern raised by RCC's bankruptcy filing and to take the necessary precautions to ensure that such bankruptcy procedure will not hinder a duly authorized permanent transfer of the equipment.
