SUBJECT: NORTH ANNA NUCLEAR STATION - REPLY TO DENIAL

OF NON-CITED VIOLATION AND CLAIM OF BACKFIT - NRC INSPECTION REPORT 50-338/01-09, 50-339/01-09

Dear Mr. Christian:

Thank you for your response of February 5, 2002, to our Non-Cited Violation (NCV) issued on January 11, 2001, in NRC Inspection Report 50-338/01-09, 50-339/01-09. In your response, you stated your basis for disputing the violation and provided your views in support of your claim of a backfit.

We have reviewed your response in detail. An NRC backfit review panel considered your backfit claim. The backfit review panel was chaired by Mr. Loren Plisco, Director, Division of Reactor Projects, and included other members of the NRC Region II staff. Given the relationship between the NCV denial and backfit claim, the panel also reviewed the response to your denial.

After careful consideration of the bases for your denial of the violation, we have concluded that NCV 50-338,339/01-09-01 should be withdrawn. We reviewed your response, as well as Figure 2 of Revision 7 of the Physical Security Plan, and determined that the condition observed was consistent with the Physical Security Plan, and was therefore, not a violation of regulatory requirements.

It was also concluded that imposition of a backfit was not appropriate based upon prior NRC positions related to this matter published in NUREG-0908.
