FINAL SUMMARY OF INFORMATION COLLECTION REQUEST

Title: DOE/NRC Forms 741 and 741A, "Nuclear Material Transaction Report," and DOE/NRC Form 740M, "Concise Note" and NUREG/BR-0006, Instructions for Completing Nuclear Material Transaction Reports and Concise Note" (Forms DOE/NRC-741, 741A and 740M)

Reasons for Changes in Burden/Responses: The overall burden estimate has not changed for DOE/NRC Forms 741/741A. There has been an increase in the cost (from \$4,416,500 to \$5,256,000) as a result of an increase in the hourly rate from \$121/hour to \$144/hour.

The overall burden estimate for DOE/NRC Form 740M has decreased by 742 hours from 855 to 113 hours because the number of licensees has decreased by 23, from 38 to 15, and based on the actual number of forms received during the past 3 years, the average number of forms submitted per licensee has decreased by 20, from 30 to 10. The estimated number of responses for NRC Form 740M has decreased from 1,140 to 150, a reduction of 990 responses. There has been a decrease of \$116,340 in the cost for DOE/NRC Form 740M from \$137,940 (\$121/hour times 1,140 responses) to \$21,600 (\$144/hour times 150 responses).

Abstract: NRC and Agreement State licensees are required to make inventory and accounting reports on DOE/NRC Forms 741 and 741A for certain source or special nuclear material (SNM) inventory changes, for transfers or receipts of SNM, or for the transfer or receipt of 1 kilogram or more of source material. Licensees affected by 10 CFR Part 75 and related sections of Parts 40, 50, 70, and 150 are required to submit DOE/NRC Form 740M to inform the U.S. or the IAEA of any qualifying statement or exception to any of the data contained in any other reporting form required under the U.S./IAEA Safeguards Agreement.
