Dear Mr. Herrera:

I am responding on behalf of the U.S. Nuclear Regulatory Commission (NRC) to your letter of March 29, 2002. In your letter, you expressed a concern that, although NRC would be conducting public meetings on April 8-10, 2002, on the potential repository at Yucca Mountain in Beatty, Tonopah, and Ely, a public meeting would not be held in Clark County.

Although NRC is not holding a public meeting in Clark County at this time, NRC has held numerous public meetings in Las Vegas and other venues within Clark County (Enclosures 1 and 2 are a listing), and we will continue to do so. It is because the vast majority of our public meetings take place in Las Vegas that we have received specific invitations to journey to neighboring towns and counties. Local officials outside of Las Vegas have asked us to present the same information and to provide their citizens with the same access to NRC staff and managers that we have afforded residents in and near Las Vegas. Just last May we responded to such a request from officials in Mesquite. We scheduled these meetings in Beatty, Tonopah and Ely in response to similar invitations from officials in Nye and White Pine counties. These public meetings were similar to meetings held in Clark County.

On March 29, 2002, before we received your letter, NRC published a draft Yucca Mountain Review Plan for public comment. We announced our intent to conduct public meetings in Nevada during the public comment period. At least two of these meetings will be held in Las Vegas, most likely in mid-to-late May.

The Commission fully agrees that its future meetings in Nevada should continue to include an ongoing dialogue with the residents of Clark County. I want to assure you that NRC values public input and welcomes the opportunity to interact with all members of the public in Nevada.
