ORDER (Denying Petitioner Jeannine Honicker's Request to File a Reply)

On April 9, 2002, Petitioner Jeannine Honicker filed by e-mail a request to reply to the response of the Tennessee Valley Authority (TVA) to her proposed contentions. TVA opposes her motion arguing that Mrs. Honicker has failed to make the necessary good cause showing that her motion should be granted.¹

In the future, the Board expects the Staff, as a party to the proceeding, to file written pleadings stating its position, or lack thereof, on any matters before the Board. The Board trusts that it will not need to address this subject again.
