The purpose of this modification is to allow Getronics Government Solutions, LLP, to provide the NRC with a replacement teleconferencing system, to include installation, system documentation, a one-year warranty, and training for nine (9) NRC personnel. As a result, the ceiling amount of Option Year 1 is increased by \$200,243.09 from \$604,689.41 to \$804,932.50 and the ceiling amount of the contract (Base Year and Option Year 1) is increased by \$200,243.09 from \$1,221,048.25 to \$1,421,291.34. The obligated amount of the contract is increased by \$200,000.00 from \$975,645.40 to \$1,175,645.40.

In addition, this modification provides for the incorporation of a one-year maintenance period for the teleconferencing system under Option Year 2, 3, and 4, which shall be exercised at the option of the Government at the price reflected in the Schedule.

By virtue of this modification, the contractor is hereby notified that:

- (1) the Project Manager identified under Paragraph H.5 - Key Personnel, of the subject contract, does not require an "L" security clearance as previously reflected under Modification No. 9; and
- (2) the NRC is hereby incorporating under this contract Paragraph H.25 entitled "Contractor Use of NRC-Furnished Information Technology Equipment".

Accordingly, the following changes are hereby made:

1. Under Paragraph C.1 - Statement of Work for Operations Center Information Management System (OCIMS), is hereby amended to allow the contractor to provide the NRC with a teleconferencing system, to include installation, documentation, a one-year warranty, and training, as reflected in its January 30, 2002, technical proposal and subsequent amendments. In addition, this modification incorporates an optional requirement for a one-year maintenance period for the teleconferencing system under Option Year 2, 3, and 4 of the contract. Should the NRC exercise the optional requirement for maintenance services, the contractor will be notified by the NRC Contracting Officer, in writing, within 30-days of the expiration date of the current maintenance period.

The warranty period for the teleconferencing system begins upon acceptance of the system by the NRC Project Officer. The maintenance period incorporated under Option Year 2, if exercised by the Government, will begin one-year from the date of expiration of the warranty period.

2. Under Section B - SUPPLIES OR SERVICES AND PRICES/COSTS, Paragraph B.3 - Schedule of Prices, is hereby deleted in its entirety and substituted in lieu thereof the Attachment to this modification.

3. Under Section B - SUPPLIES OR SERVICES AND PRICES/COSTS, Paragraph B.4 - Consideration and Obligation-Cost Plus Fixed Fee, Subparagraphs (a) and (c) are hereby deleted in their entirety and substituted in lieu thereof the following:

"B.4 CONSIDERATION AND OBLIGATION

(a) The total estimated cost to the Government for full performance of this contract is \$1,421,291.34, of which the sum of \$1,341,600.86 represents the reimbursable costs and of which \$79,690.48 represents the fixed fee.

(c) The amount currently obligated by the Government with respect to this contract is \$1,175,645.40, of which the sum of \$1,109,993.61 represents the reimbursable costs and of which \$65,651.79 represents the fixed fee."

4. Under Section H - SPECIAL CONTRACT REQUIREMENTS, Paragraph H.25 is hereby incorporated as follows:

"H.25 APPROPRIATE USE OF GOVERNMENT FURNISHED INFORMATION TECHNOLOGY (IT) EQUIPMENT AND/ OR IT SERVICES/ ACCESS (MARCH 2002)

As part of contract performance the NRC may provide the contractor with information technology (IT) equipment and IT services or IT access as identified in the solicitation or subsequently as identified in the contract or delivery order. Government furnished IT equipment, or IT services, or IT access may include but is not limited to computers, copiers, facsimile machines, printers, pagers, software, phones, Internet access and use, and email access and use. The contractor (including the contractor's employees, consultants and subcontractors) shall use the government furnished IT equipment, and / or IT provided services, and/ or IT access solely to perform the necessary efforts required under the contract. The contractor (including the contractor's employees, consultants and subcontractors) are prohibited from engaging or using the government IT equipment and government provided IT services or IT access for any personal use, misuse, abuses or any other unauthorized usage.

The contractor is responsible for monitoring its employees, consultants and subcontractors to ensure that government furnished IT equipment and/ or IT services, and/ or IT access are not being used for personal use, misused or abused. The government reserves the right to withdraw or suspend the use of its government furnished IT equipment, IT services and/ or IT access arising from contractor personal usage, or misuse or abuse; and/ or to disallow any payments associated with contractor (including the contractor's employees, consultants and subcontractors) personal usage, misuses or abuses of IT equipment, IT services and/ or IT access; and/ or to terminate for cause the contract or delivery order arising from violation of this provision."
