Fred Burrows and Bill Gleaves have been contributors to the mixed oxide (MOX) fuel fabrication facility project license review in the areas of electrical/instrumentation and controls and mechanical systems, respectively. We are currently completing the review of the MOX facility construction authorization request and preparation of a safety evaluation report. We expect the construction review will continue through fiscal year (FY) 2003. We request continued support from Messrs. Burrows and Gleaves for the duration of the construction authorization review in the areas in which they are now contributing. We estimate that this effort will take about 0.2 full time equivalents (FTE) per year for Mr. Burrows in FY2002 and FY2003 and 0.3 FTE per year for Mr. Gleaves in FY2002 and FY2003. The TAC numbers currently being used will remain the same.
