Dear Mr. Dolan:

The Commission has issued the enclosed Amendment No. 32 to Facility Operating License No. DPR-58 and Amendment No. 13 to Facility Operating License No. DPR-74 for the Donald C. Cook Nuclear Plant, Unit Nos. 1 and 2, respectively. The amendments consist of changes to the Technical Specifications in response to your application transmitted by letter dated November 22, 1978 as supplemented by letters dated January 22, January 24, April 16, June 29, July 27, September 11, September 26 and September 27, 1979.

These amendments permit modification of the spent fuel pool which will increase the storage capacity for fuel irradiated at D. C. Cook from 550 to 2050 fuel assemblies.

Copies of the Safety Evaluation, Environmental Impact Appraisal and the Notice of Issuance and Negative Declaration are also enclosed.
