

SECTION 3.0.4 AND 4.0.4

On July 30, 1981, a "Notice of Issuance of Amendment to Facility Operating License" was published on page 46FR40112 (August 6, 1981) which incorrectly referenced the Amendment No. and Docket No. The correct Amendment No. should have been Amendment No. 33 instead of Amendment No. 49.
