NOTIFICATION AND SURVEILLANCE PLAN FOR BECHTEL SAIC COMPANY, LLC (BSC) QUALITY ASSURANCE (QA) SUPPLIER SURVEILLANCE BSCQA-02-S-19 OF LABORATORY TESTING, INC.

BSC QA will conduct a surveillance of the Laboratory Testing, Inc. (LTI) facility in Hatfield, Pennsylvania on April 23, 2002, to measure the effectiveness of the QA program implementation as delineated in BSC Purchase Order 24540-160-PO-01195, List of Items dated February 14, 2002. The scope of the surveillance will be an evaluation of the implementation of the BSC purchase order and LTI quality program requirements for the receipt inspection and fabrication of metal specimens. LTI's personnel are encouraged to immediately correct any identified conditions adverse to quality during the surveillance to prevent the need for future follow-up activities.

In addition, observers from the State of Nevada, U.S. Nuclear Regulatory Commission, and other interested parties may accompany the surveillance team.
