

My name is Blaine N. Howard and I am a health physicist now retired. I was an AEC Graduate Fellow in Radiological Physics at the University of Rochester and Brookhaven National Laboratory in 1953-54 and have been certified by the Americal Board of Health Physics although my certification is not current since my retirement

I feel that the major problem with public acceptance of a storage site for the spent fuel is the unreasonable fear of radiation based on false concepts which have been so prevalent. It is my hope to give some practical information to help dispell this fear.
