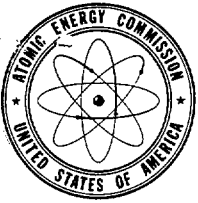

ORDER EXTENDING PROVISIONAL CONSTRUCTION PERMIT COMPLETION DATE

By application dated April 6, 1970, Commonwealth Edison Company requested an extension of the latest completion date specified in Provisional Construction Permit No. CPPR-22. The permit authorizes Commonwealth Edison Company to construct a single cycle, boiling water nuclear reactor, known as Dresden Unit 3, at the Dresden Nuclear Power Station in Grundy County, Illinois.

Good cause having been shown for this extension pursuant to Section 185 of the Atomic Energy Act of 1954, as amended, and Section 50.55(b) of 10 CFR Part 50 of the Commission's regulations, IT IS HEREBY ORDERED THAT the latest completion date specified in Provisional Construction Permit No. CPPR-22 is extended from June 1, 1970 to December 1, 1970.
