SUBJECT: REFORMATTED TECHNICAL SPECIFICATIONS

Re: Dresden Nuclear Power Station, Unit Nos. 2 and 3

The Commission has issued the enclosed Amendment No. 82 to Provisional Operating License No. DPR-19 for Dresden Unit 2 and Amendment No. 75 to Facility Operating License No. DPR-25 for Dresden Unit 3. The amendments consist of changes to the Technical Specifications in response to your application dated June 11, 1984.

The amendments authorize approval of new versions of the Technical Specifications for Dresden Units 2 and 3. The Technical Specifications are revised, without changing the technical content, into a format which will have and continue to have in the future improved legibility and versatility.

The staff reviewed the new versions of the Technical Specifications by comparing them, word for word, with the present License Authority copies. During this review process, typographical and minor grammatical errors which appeared in the present License Authority copies were corrected. Page changes when future amendments are submitted will be greatly simplified and textual clarity will be enhanced. As indicated above, there are no changes in the technical content.

This amendment involves changes in the recordkeeping, reporting, and administrative procedures and requirements. Accordingly, this amendment meets the eligibility criteria for categorical exclusion set forth in 10 CFR 51.22(c)(10). Pursuant to 10 CFR 51.22(b) no environmental impact statement or environmental assessment need be prepared in connection with the issuance of this amendment.

No request for hearing was received and no comments were received.

This action will appear in the Commission's Monthly Notice publication in the Federal Register.

AMENDMENT TO FACILITY OPERATING LICENSE

Amendment No. 75
License No. DPR-25

1. The Nuclear Regulatory Commission (the Commission) has found that:
 - A. The application for amendment by the Commonwealth Edison Company (the licensee) dated June 11, 1984 complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the act), and the Commission's rules and regulations set forth in 10 CFR Chapter I;
 - B. The facility will operate in conformity with the application, the provisions of the Act and the rules and regulations of the Commission;
 - C. There is reasonable assurance (i) that the activities authorized by this amendment can be conducted without endangering the health and safety of the public, and (ii) that such activities will be conducted in compliance with the Commission's regulations;
 - D. The issuance of this amendment will not be inimical to the common defense and security or to the health and safety of the public;
 - E. The issuance of this amendment is in accordance with 10 CFR Part 51 of the Commission's regulations and all applicable requirements have been satisfied.


2. Accordingly, the license is amended by changes to the Technical Specifications as indicated in the attachment to the license amendment and paragraph 3.B of Facility Operating License No. DPR-25 is hereby amended to read as follows:

B. Technical Specifications

The Technical Specifications contained in Appendix A, as revised through Amendment No. 75, are hereby incorporated in the license. The licensee shall operate the facility in accordance with the Technical Specifications.

3. This license amendment is effective as of the date of its issuance.
